Integrated Inventory Solutions flagship ERP software suite, INxSQL (pronounced in-sequel), is a fully-integrated system tailored toward the specific demands of distributors, wholesalers, and industrial resellers.

INxSQL is developed using the Microsoft .NET platform, the company expects that building the software this way will mean most users will be more familiar with the interface. A key feature of the ERP is the management dashboard, this real-time data display offers a range of reports on the company's performance, some of which include a daily snapshot, inquiries by customers, and inquiries by a vendor.

Using Microsoft's industry-standard SQL Server database and Visual Studio, INxSQL can be integrated with UPS WorldShip and FedEx systems, supports territory sales operations through remote database synchronization (orders sent in; price changes, quantities, and customer data sent back), and features a dedicated EDI application.

INxSQL is installed on-premise, upon selection of the ERP Integrated Inventory Solutions provides a project manager to support the IT department with hardware installation and software requirements.
